## SELLER AGREEMENTS

*This puppy/dog is a purebred animal. This puppy/dog is of typical temperament and structure, and embodies the basic standards of the breed.*

The purchase price of this puppy/dog will be refunded if the buyer furnishes the Seller with a veterinary certificate indicating that the puppy/dog has a life-threatening congenital defect or virus, and returns the puppy/dog to the Seller within 72 hours of delivery. Seller does not guarantee against communicable diseases beyond 72 hours of Buyers receiving puppy/dog. No veterinary or shipping costs will be reimbursed by Seller.*

*If the buyer has paid by check, the purchase price will be refunded only if or when the buyer's check has cleared and been credited to the Seller's account. Seller guarantees for 1 year against a heart murmur or mitral valve disease.*

*Seller does not guarantee against non-threatening puppy maladies i.e. parasites, slipped stifles, hernias, missing or misaligned teeth.*

*Seller does not guarantee against avoidable disease caused by improper care or neglect by the buyer i.e. hypoglycemia/hypothermia and the auto-immune system and major organs or death hypoglycemia often causes. It is the buyers responsibility to feed puppy/dog every 3 hours, ( force feed if necessary and give Nutri-stat 4X day and night) not over-play the puppy and to keep puppy warm at all times and to provide immediate veterinary assistance if glucose is needed.*

*The puppy/dog is healthily at the time of sale and has had the immunizations enumerated in the attached health information. Seller agrees to provide vaccination record and protocol. Any deviation from the protocol will void any guarantee expressed or implied regarding said puppy.*

*At no time will the puppy be given a shot containing Leptospirosis Corona virus.*

*Seller in no way guarantees that this puppy/dog shall win in conformation and/or performance events.*

*Seller on no way guarantees size of puppy/dog nor his/her adult weight nor height.*

*Seller agrees to provide advise and information about showing and grooming to the best of his/her ability, to help the buyer of a show or performance potential puppy/dog to present the puppy/dog to its best advantage.*

*No other warranties or guarantees, expressed or implied, are made under this contact except as stated above. Signed by*

## BUYER AGREEMENTS:

*Buyer agrees that if at any time, and for any reason, he/she is unable to keep or properly care for the puppy/dog, Seller shall have first right of refusal.*

*The Buyer agrees to maintain the puppy/dog's health with yearly vaccinations and dentals as specified by their veterinarian. Should the puppy/dog become ill or unsound, any and all costs of treatment will be the responsibility of the buyer and not reimbursed by the seller at any time.*

*The buyer acknowledges that no veterinary bills incurred by the Buyer will be paid by the Seller at the time throughout said puppy/dog's life.*

*The Buyer agrees to feed only those puppy/dog foods acceptable to the Seller, and in particular, agrees not at any time to feed the puppy/dog a "raw", "BARF", vegetable, or home-cooked diet.*

*The Buyer agrees to contact the Seller about any changes to the puppy/dog's diet.*

*The Buyer agrees to maintain the puppy indoors and provide an exercise pen or human baby play pen with proper bedding, for puppy to eat and rest.*

*Buyer acknowledges that all risk of loss pertaining to the mobility, illness, or injury at any time of said puppy shall remain upon Buyer. Buyer agrees to indemnify and hold harmless Seller, Seller's agents, servants, employees, and representatives, from any and all loss, damage, and expense whatsoever from all acts of any kind whatsoever, any all claims, presentation or demand from any person whomever, including Buyer, arising out of having to do with the prior or present care, housing, breeding, training, mortality, capacity, and health of the said puppy/dog.*

*Buyer acknowledges that special coat care, conditioning, training and feeding are necessary to produce a competitive animal in conformation and performance events. This care and training is acknowledged by the Buyer to be his/her responsibility.*

*If this animal is sold for showing or breeding, all resulting offspring will be sold with limited AKC registration only, except the offspring directly retained in full ownership of Buyer.*
